7. Moot Court, Pre-Trial Preparation and Participation In Trial Procedures (Practical Training , Case diary and viva-voce)

- I. Moot court (15 Marks). Every student may be required to do at least two moot courts in a year. The moot court work will be on assigned problem .
- II. Observance of Trial in two cases, one Civil and one Criminal (15 marks): Students may be required to attend two trials in the course of the last two or three years of LL.B. studies. They will maintain a record and enter the various steps observed during their attendance on different days in the court assignment.
- III. Interviewing techniques and Pre-trial preparations and Internship diary (20 marks): Each student will observe two interviewing sessions of clients at the Lawyer's Office/Legal Aid Office and record the proceedings in a diary. Each student will further observe the preparation of documents and court papers by the Advocate and the procedure for the filing of the suit/petition.
Note: I, II and III will be recorded in the dairy which shall comprise of 50 marks in total. (15+15+20)
- IV. The fourth component of this paper will be Viva Voce examination on all the above three aspects. This will carry 50 marks.

ALLAHABAD STATE UNIVERSITY

Ordinance for the Degree of Bachelor of laws

(Three years course form academic session 20)

1. The examination for the Degree of Bachelor of laws shall consist of three academic sessions and each academic session shall consist of two semesters.
2. A Candidate who after graduating either in Arts in Science, in commerce in engineering in medicine or in Agriculture from this university or from any other university, whose degree is recognised by this university as equivalent thereto, has completed the prescribed course of studies in this university for the first as well as second semester may be permitted to appear for the LLB first semester and second semester examination respectively.
3. The candidate who, after having cleared the first and second semester examination of Allahabad state university or is entitled for promotion to third and fourth semester examination (as per ordinances for second examinations has completed the prescribed course of studies in Allahabad State University for third and fourth semester, may be permitted to appear for LLB. third and fourth semester examinations respectively.
4. A candidate who after having cleared all the subjects for first and second semester examination and is entitled for promotion to fifth and sixth semester examinations (as per ordinance for second examination



has completed the prescribed course of studies in Allahabad State University for fifth and sixth semester examination respectively.

5. No candidate shall be permitted to appear at the LL.B first semester or second semester or Third semester or fourth semester or fifth semester or sixth semester examinations unless he has attended in the Law Department of Allahabad State University or an Associated college authorised by this university to impart instructions for LL.B Degree course the minimum number of lectures or practical or tutorials as the case may be for this purpose.

9. For the purpose of examinations for the Degree of Bachelor of Laws. A paper shall be set for each semester and the examinations for the First/Third/Fifth Semester in the end November and for the second/Fourth/Sixth Semester in the First week of May during each Academic Session 100 Marks will be assigned to each subject of Study, as prescribed by the Departmental Committee. For every Academic Session)

10. In order to pass LL.B. First/Second Semester or LL.B Third/Fourth Semester or LL.B Fifth/Sixth Semester Examinations a candidate must obtain a minimum of 36% marks in each subject of study and a minimum of 45% marks in the aggregate.

Those of the successful candidates who obtain in the aggregate 45% marks or above but below 60% shall be placed in Second division and those of the successful candidates who obtain 60% marks or above shall be placed in the First division.

Provided that the division of the candidates shall be determined at the end of the sixth semester examination on the basis of aggregate of marks obtained in all the six semester examinations.
